Waiver and Release by Legal Guardian or Parent

I hereby represent that I am the parent or legal guardian of _____,
(who is 17 years old or younger) (the "Motorcycle Rider") and am authorized to execute this Waiver
and Release. I do further agree and represent that:

1. The Motorcycle Rider is physically able to safely ride and use the Leased Property.
2. I have read and understand the Southern Dirt Rider Association, LLC's Release Agreement,
the terms of which are expressly incorporated herein, which has been executed by the
Motorcycle Rider and witnessed by me and one other adult.
3. I have read this document.
4. I voluntarily signed this Waiver and Release.
5. If the Motorcycle Rider is below 16 years of age he or she will be supervised by a parent or
legal guardian at all times while participating in the activities contemplated by the Release
Agreement and this Waiver and Release.

In consideration of said Motorcycle Rider being allowed to use the Leased Property, the
undersigned, on behalf of myself and said Motorcycle Rider, release the Releasees (as defined and
described in the Southern Dirt Rider Association, LLC Release Agreement) executed by and between
SDRA, LLC and the Motorcycle Rider from all liability to me and/or said Motorcycle Rider or other
legal beneficiary of said Motorcycle Rider, including any and all liability for any loss, damage,
expense or injury, including death, that we may suffer or that our next of kin may suffer, as a result
of Motorcycle Riders' participation, DUE TO ANY CAUSE WHATSOEVER, INCLUDING
NEGLIGENCE, BREACH OF CONTRACT, OR BREACH OF ANY STATUTORY OR OTHER
DUTY OF CARE, AND FURTHER INCLUDING THE FAILURE ON THE PART OF THE
RELEASEES TO SAFEGUARD OR PROTECT ME FROM THE RISKS, DANGERS AND
HAZARDS OF MOTORCYCLE RIDING TO ABOVE. I further agree to indemnify, save and hold
Releasees harmless from any loss, liability, attorneys' fees, damage, or costs that they (or any of
them) may incur arising out of or related to the use of the Leased Property by said Motorcycle Rider
whether caused by the negligence of the Releasees or otherwise.

By execution of this Waiver and Release, I agree that the terms, conditions, waivers, and
releases of the referenced Release Agreement executed by the said Motorcycle Rider and at least one
parent or legal guardian, are incorporated herein as a part of this Waiver and Release. This waiver is
valid for one year from signed date.
